General WSK Declaration (*)

Pursuant to the Act of 29 November 2000 on foreign trade in goods, technologies and services of strategic importance to the security of the State and to maintaining international peace and security (consolidate text Journal of Laws [Dz. U.] of 2004, No 229, item 2315), hereinafter referred to as the „Act”,

and pursuant to the Council Regulation (EC) No 1334/2000 of 22 June 2000 setting up a Community regime for the control of exports of dual-use items and technology (OJ EC L 159, 30.6.2000, as amended)

in connection with the obligation to keep records of the trade in goods of strategic importance, imposed on DHL Global Forwarding Sp. z o. o. as a forwarder providing brokerage services (Art. 25 section 1 of the Act);

..... (hereinafter referred to as the „**Principal**”) shall:

- notify DHL Global Forwarding Sp. z o. o. with prior notice of any parcel entrusted to the forwarder, which is an item of strategic importance within the meaning of the Act; and
- provide at the request of DHL Global Forwarding Sp. z o. o. information and documents necessary to handle and keep records of the trade in goods of strategic importance under the Regulation of the Minister of Economy and Labour of 1 October 2004 on the records of trade in items of strategic importance (Journal of Laws [Dz.U.] No 231, item 2319).

The aforementioned obligations shall apply to each and every kind of trade (within the meaning of Art.3 section.8 of the Act) and each and every brokerage service (within the meaning of Art.3 section 5(a) of the Act) to be provided by DHL Global Forwarding Sp. z o. o. to the Principal.

Simultaneously, the Principal declares that the failure to provide a prior notice referred to in hereinabove, shall imply that DHL Global Forwarding Sp. z o. o. should consider a given parcel as not containing any goods of strategic importance.

(*) The abovementioned declaration is necessary for DHL Global Forwarding Sp. z o. o. to provide legal forwarding services in the foreign trade area. The Act of 29 November 2000 referred hereinabove, imposes an obligation to keep records of all the trade in goods of strategic importance. Under this Act:

1/ natural or legal person pursuing trade in goods of strategic importance is obliged to **keep records** of this trade (Art.25 section 1 of the Act)

2/ **trade** means a brokering service [Art.3 section 8 (b)]

3/ **a brokering service** means activities taken up by natural or legal persons and consisting in:

- a) negotiating, business consulting, and assistance in conclusion of contracts, as well as any form of participation in activities related to export, import, transit or conclusion of any lease, donation, loan, or bailment agreement, as well to any contributions in kind, which may in particular refer to the transfer of items of strategic importance from one country to another,
- b) purchase, sale or organisation of any transfer, and in particular forwarding, of items of strategic importance from one country to another [Art. 3 section 5(a)]
